### **General Instructions**

**1. All applications should be accompanied by the prescribed fee.**

**2. The fee once paid will not be refunded or adjusted under any circumstances.**

**3. Remittance of Examination Fee:**

a)The Principal / Head of the Institution should collect Examination fee from all the candidates and remit the consolidated amount to the University Fund through **Demand Draft drawn in favour of “SBI-KUHS Examination Fee Account 31768842875”, payable at Thrissur.**

b) The Principal / Head of the Institution should send a separate statement showing the details of those SC/ST/OEC candidates who are not remitting the examination fee with an undertaking that their examination fee will be claimed by the College from the Department concerned and remit the same to the University.

c) **The institutions which are not recognised as University Examination Centre for theory examinations have to remit an additional amount of Rs. 100/-per candidate per paper to the University for using another approved centre.**

**d) No other fees should be collected from the candidates.**

**4. Admit Card:**

**Admit cards will be issued to all colleges through online.** The Principal / Head of Institution should download the Admit card and distribute the same among the candidates after getting their signature and countersigned by the Principal with College seal.

**5. Applications after the stipulated date will not be entertained on any grounds.**
